#### 1. DETERMINATION OF THE PHARMACEUTICAL PRODUCT

1.1 Name: RELIEF

1.2 Composition: Active ingredient: Thiocolchicoside

Excipients: Ethanol 95°, Trolamine, Carbopol 980, Water purified.

1.3 Pharmaceutical form: Gel

1.4 Content in active agent: Each gram of gel contains 2.5 mg thiocolchicoside (percentage of 0.25% w/w)

**1.5 Description – Packaging:** Yellowish gel packaged in aluminum tube with plastic screwed cap. The tube bears the characteristics of the product and the lot printed and contains 60 gr of gel. Each box contains a tube and a patient information leaflet.

1.6 Pharmacotherapeutic category: Muscle relaxant acting centrally

# 2. WHAT YOU NEED TO KNOW ABOUT THE MEDICINE PRESCRIBED BY YOUR DOCTOR

#### 2.1 General information

RELIEF contains the active agent thiocolchicoside, which brings a progressive relaxation of the muscles in rheumatic conditions accompanied by muscular spasm.

# 2.2 Indications

Possibly effective as adjuvant treatment for the relief of muscular pain accompanying conditions such as:

a) Acute or chronic rheumatopathy, inflammatory or not, such as: rheumatoid arthritis, osteoarthritis, ankylopoletic arthritis, lumbago or ischialgia

b) Pain from muscular spasm

# 2.3 Contraindications:

- · Known hypersensitivity to thiocolchicoside or any of the excipients
- Pregnancy and lactation (see 2.4.2 and 2.4.3 "Pregnancy and lactation")
- · Flaccid paresis, muscular hypotonia
- · Children

# 2.4 Special precautions and warnings for use

#### 2.4.1 General:

<u>Precautions:</u> Lowering of the dose is required in the case of diarrhoea.

<u>Warnings:</u> RELIEF can predispose to spasm in patients with epilepsy or patients at risk for seizures.

- 2.4.2 Pregnancy: Contraindicated during pregnancy
- 2.4.3 Lactation: Contraindicated during lactation
- 2.4.4 Effects on ability to drive and use machines: Due to the insignificant absorption in local applications, no systematic effects are expected. Caution is recommended for possible suppressing effect before driving and using machines.
- 2.4.5 Children: See 2.6. "Posology and method of administration"

#### 2.5 Interactions with other medicines or substances

# 2.6 Posology and method of administration:

Method of administration: Skin use

Posology: The posology is customized according to each patient's needs.

1 - 3 applications per day with a small quantity which is quickly absorbed without rubbing <u>Children:</u> The use of RELIEF gel is not recommended for children less than 15 years.

#### 2.7 Overdose - Treatment:

Points and symptoms: No overdose expected in this pharmaceutical form

<u>Treatment:</u> In case of intentional swallowing, application of general measures and symptomatic treatment are recommended.

#### 2.8 Undesirable effects

<u>Immune system disorders:</u> Anaphylactic reactions, such as pruritus, urticaria, angioedema

Nervous system disorders: Lassitude

<u>Skin and subcutaneous tissue disorders</u>: Skin allergic reactions, including photosensitivity

# 2.9 What you should know if you omit to take a dose

If you take the medicine regularly and you omit a dose, you should take it as soon as possible. If, however, the time for the next dose is close, do not take the omitted dose, but continue the treatment as scheduled.

#### Do not take double doses.

# 2.10 What you should know about the expiry date of the product

Written on the inner and outer package. If the expiry date has elapsed, do not use the medicine.

#### 2.11 Special precautions for the storage of the product

This medicine should be stored at room temperature away from children.
